

Telstra Alumni Website Launch 2017 Promotion - Terms and Conditions

1. Information on how to enter and prize details form part of these terms and conditions. By entering this promotion you are deemed to have accepted these terms and conditions.
2. This promotion is being run by Telstra Corporation Limited (ABN 33 051 775 556) of 400, George Street, Sydney NSW 2000 ("**we**", "**us**" or "**our**").
3. The promotion starts 1.00 pm AEST on 1 June, 2017 and closes at 1.00 pm AEST on 31 July 2017 ("**promotion period**"). Entries must be received during the promotion period.

Who can enter?

4. Entry is open to all Australian residents who are existing Telstra Alumni members, over the age of 18.

How do you enter?

5. To enter, you must, during the promotion period:

Eligible entry

6. Only one entry per person will be accepted.
